Beginnings

Kalpavriksh is a non-governmental organisation working in the area of environment education, research, campaigns, and direct action. It began in 1979, with a youth campaign to save Delhi's Ridge Forest area from encroachments and destruction. Starting with these roots in local action, Kalpavriksh has moved on to work on a number of local, national, and global issues. Kalpavriksh is registered under the Societies Registration Act of 1980 (No. S-17439). While its offices are currently in Pune, its members are based across India and some other countries.

Philosophy

Kalpavriksh believes that a country can develop meaningfully only when ecological sustainability and social equity are guaranteed, and a sense of respect for and oneness with nature and fellow humans is achieved.

Governance

Kalpavriksh is a non-hierarchical organisation. One of the working principles that emanated from the philosophy of the group was a democratic decision-making process. All decisions are taken during group meetings and based on group consensus.

B1.a Strengthening Community Conserved Areas in Nagaland via Field Interventions, Technology and Policy Support

Kalpavriksh, along with local partners Kenono Foundation and Lemsachenlok, and supported by The Nature Conservancy started an on-ground project in Nagaland focused on strengthening the ability of communities and organisations in the state to protect and manage their CCAs. The following activities were undertaken during this FY:



1. Documenting Current Status of Biodiversity and Human-Wildlife Interactions

Five Community Conserved Areas (CCAs) were identified for in-depth work during the project. The spatial boundaries of each CCA were documented. To monitor biodiversity, we assessed the necessary capacity needs and material support, leading to the development of a comprehensive biodiversity monitoring plan. This plan, including data security protocols, is now being implemented by trained community resource persons. Additionally, we rolled out a capacity-building program aimed at equipping community members with the skills needed to implement the monitoring plan effectively. Key resource persons within the communities were identified and trained for the monitoring process.

Community-led comprehensive biodiversity surveys are being conducted using camera trapping and interview methodologies. Through the analysis of this data we hope to get key statistics providing valuable insights into the biodiversity of the CCAs. Furthermore, we are conducting questionnaire-based surveys to evaluate community perceptions of human-wildlife conflict. The amount and type of prevalent human-wildlife coexistence and conflict will be identified, which can feed into targeted interventions in future.

2. Evaluating Social Equity in CCA Management

We completed a general analysis of social equity in Nagaland, specifically in the context of CCAs and natural resource management. This analysis led to the identification of specific methods for incorporating social equity into project activities, which are now being implemented. Periodic capacity-building programs with a focus on social equity and gender sensitivity were undertaken for the field staff.

3. Evaluating Management Plans and Sustainable Funding Mechanisms for CCAs

We evaluated existing CCA management plans to ensure they meet the current needs of conservation and communities, including equity considerations. Necessary modifications to existing management plans are being developed. An annual budget estimate for the activities identified will also be developed, and potential funding sources identified, along with strategies to address any budget shortfalls.

The project will also focus on identifying opportunities for financial mechanisms to support CCAs, considering community aspirations, local market conditions, and potential to meet budget shortfalls.

4. Strengthening NCCAF's Technical Assistance to CCAs



To enhance the technical assistance provided by the Nagaland Community Conserved Areas Forum (NCCAF) to communities, we identified and developed guidance documents on three key topics: CCAs and Community Reserves, Carbon Markets and Community Self-Documentation.

5. Upgrading Portal Documenting 30 CCAs

We incorporated a webGIS map module into the CCA portal, added additional spatial layers, and implemented a customizable dashboard. A beta version of a microsite featuring CCAs of Nagaland was successfully deployed. This upgraded portal now serves as a vital resource for aggregating and disseminating information on CCAs in Nagaland.

Local resource persons were trained to anchor the documentation process, and a complete set of data, including spatial boundaries and other relevant information, was collected and entered into the CCA portal. This initiative has significantly enhanced the database of CCAs in Nagaland, making crucial information accessible to stakeholders.

6. Future Plans

Along with completing the ongoing activities described above, we will be organising an event to hold a visioning exercise for CCAs in Nagaland to set the direction for future initiatives and reinforce our commitment to sustainable CCA management.

B.1b CCA Web Portal

The CCA web portal was ideated upon and developed with the following objectives:

- To increase the recognition of CCAs and highlight their importance vis-à-vis community well-being, biodiversity conservation, ecosystem restoration and climate change
- To create a repository of local knowledge that enables learning and exchange of information
- To serve as an evidence-base for community-led approaches to conservation and impact the global policy sphere

In the last FY, several advancements on the portal were made, both in terms of technical features as well as a huge increase in the number of documentations.

1. <u>TECHNOLOGICAL OUTPUTS</u>

a. **Microsites**: a dedicated space to highlight collectives/organisations working on defending, sustaining and documentation of CCAs. In the current phase, two microsites were developed.



- i. <u>Seva Mandir</u>: an NGO working with local communities in southern Rajasthan towards strengthening local governance systems and improving livelihoods
- ii. <u>Nagaland Community Conserved Areas Forum (NCCAF)</u>: a state level forum led by indigenous peoples and local communities to facilitate learning and sharing exchanges on laws, policies and any other issue relevant to CCAs in the state
- b. Dashboard: Data analytics of all the CCAs that are documented on the portal. The information is shown through charts and includes the state wise distribution of documented CCAs as well as CCAs listed by ecosystem type, motivations, land ownership, social impacts, and threats and challenges.
- c. Geospatial layers: an overlay of Protected Areas in India, Census data, Forest cover, Ecoregions, Biogeographic zones, Tiger landscapes, Key biodiversity areas, Protected areas and OECMs were incorporated on the CCA portal to give a broader socio-ecological and political context to CCAs in India
- d. **Resources**: a section on the relevant laws, policies and toolkits for CCAs was designed and curated.

2. DOCUMENTATION

Different kinds of methodologies are used to document CCAs on the web portal depending on the scale of documentation and depth of knowledge that the team strives to cover for CCAs. In this FY, we documented 400+ CCAs in total covering different regions across India that includes numerous in-depth documentations spanning regions such as Jammu and Kashmir, Uttarakhand, Rajasthan, Kerala, Nagaland, Meghalaya, Arunachal Pradesh etc.

The core team of the CCA web portal has undertaken a few capacity-building workshops for various organisations on the objectives and use of the portal vis-à-vis mapping, documentation as well as data entry.

B.1c Outreach and Information Exchange on CCAs

• Over the past year, we have had several conversations with UNEP-WCMC and contributed towards enhancing the ICCA registry. Discussions with various stakeholders have also centred on collaborations that bring visibility to respectives platforms.



• The CCA web portal team from Kalpavriksh presented at a webinar on Digitisation of Maps and Databases of ICCAs organised by Working Group on ICCAs, Indonesia for ICCA News Myanmar.

B.1d Strengthening the CCA Network in the Region

Several interventions were made towards this particular aspect of our work that spans across local, national and international levels.

1. <u>NATIONAL-LEVEL WORKSHOP ON COMMUNITY CONSERVED AREAS</u>

An in-person National-level workshop on Community Conserved Areas was organised by Kalpavriksh and ATREE on behalf of the National Working Group on CCAs in India. The workshop took place in Bengaluru, India from 6th to 8th December 2023.

The agenda along with the logistics for the workshop was discussed and decided with members of the National Working Group. The workshop began with an ice-breaker by engaging the participants towards creating a human map with introductions and a purpose of showcasing the diversity within the group. Additionally, there was also a cultural evening where some members of the Soliga tribe from BR Hills came together for a mesmerising band performance and all the delegates joined in.

There were three objectives of the workshop as follows:

- Learning and sharing with each other about the challenges CCAs face and opportunities towards their support
- Understanding and gaining clarity on the current legal spaces for CCAs, various financial mechanisms and the politics of research and documentation
- Understanding the Kunming Montreal Global Biodiversity Framework, its implications for CCAs in India and strategising towards the future to implement this framework nationally.

The sessions during the workshop aimed to deep dive into the following topics:

- CCAs and its diversity in terms of ecosystems, governance, conservation practices and challenges
- Introduction to ICCA Consortium
- Management plans
- Various financial mechanisms (including a discussion on demystifying carbon rights and markets)
- Social inclusion and equity
- Relevant legal provisions
- Kunming-Montreal Global Biodiversity Framework



As a collective of more than 60 delegates that included community leaders, researchers, civil society organisations and experts across the country, there were discussions on developing future strategies based on the priorities that emerged from the workshop.

2. <u>STATE-LEVEL WORKSHOP ON INDIGENOUS VISIONS OF</u> <u>DEVELOPMENT AND COLLECTIVE WELLBEING FROM ARUNACHAL</u> <u>PRADESH</u>

The workshop/meeting was held on 15-17 December 2023. It focused on the Indigenous People of Arunachal Pradesh, a state in northeast India. It was a unique meeting where young Indigenous People from different ethnic groups of the state gathered to share their perspectives on a multitude of issues, such as governance systems, notions of development, role of non-humans in their present and future, intergenerational knowledge transfer, and understandings of land and forests rights.

The overarching idea was to have a deep discussion about how the ongoing 'development' articulates with Arunachal's Indigenous People's traditional worldviews, what is the collective vision of wellbeing and sustainability, and how they see their lives and lands fitting in with the ongoing climate and biodiversity extinction crisis.

Learning goals of the circle

- 1. To create a space for bringing together diverse Indigenous communities of Arunachal and facilitate sharing of perspectives, lived realities, and diverse forms of cultural expressions that enable knowledge generation and sharing.
- 2. To develop a shared understanding of threats and challenges on ground and articulation of various ways to deal with it as a collective.

Conceptualisation, preparation and agenda setting

The meeting was conceptualised via a discussion between some members of Kalpavriksh and some native youths of Arunachal Pradesh. It was followed by formation of an organising committee and rounds of discussions among the committee to turn the idea into an event. The committee was composed of representatives of Kalpavriksh and indigenous youths of Arunachal Pradesh from different ethnic groups, and from different professional backgrounds.

B.1e On-Ground Support to CCAs

Kalpavriksh secured funds to continue on ground fellowship support for self strengthening of CCAs in Uttarakhand. Four people from Van Panchayats and three Van Gujjars were supported from Holdeen funds reported in B.2.

B.2a Engagement with Laws and Policies on Protected Areas

The team undertook various engagements for outreach and networking to highlight the potential challenges of Advancing Target 3 of the Kunming Montreal Global Biodiversity Framework in absence of strong human rights based approaches. These included:

- Engagement with Target 3 with the Convention on Biological Diversity with the Women's Caucus: Meenal Tatpati
- Engagement with co-writing a Policy and white paper on Human-Elephant Coexistence with the Coexistence Consortium: Meenal Tatpati and Neema Pathak Broome
- Presented a paper titled, 'Protected Area Expansion in India: Impact of land rights and tenurial security of local communities-experiences from Kumbhalgarh Wildlife Sanctuary and Corbett Tiger Reserve at the Land and Development Conference (Land-People Relations: Diversity and Transitions)-Meenal Tatpati and Akshay Chettri
- Organised a consultation with Lokhit Pashu Palan Sanstha, Rajasthan to discuss the proposed tiger reserve at Kumbhalgarh Wildlife Sanctuary: Meenal Tatpati
- Field visit to Phulwari Ki Naal, Todgarh Raoli and Kumbhalgarh Wildlife Sanctuaries and Jawai Bandh Conservation Reserve to look at the issues of proposed tiger reserve: Meenal Tatpati and Ishika Patodi
- Engagement with groups in Maharashtra and government officials (especially from the Department of Tribal Development) on Target 3 and the status of PAs, OECMs and Critical Wildlife Habitats in Maharashtra.

B.2c Legal Interventions and On-ground Investigations

- 26th Feb-8th March: Field investigation into the awareness of villagers about the proposed Kumbhalgarh Wildlife Sanctuary, the Supreme Court order on consolidation of deemed forest land and issues around Protected Areas. Visited Puhulwari Ki Naal, Todgarh Raoli and Kumbhalgarh Wildlife Sanctuaries and Jawai Bandh Conservation Reserve: Meenal Tatpati
- Supported local community-members with evidence collection, advocacy strategies and visits to gram sabhas in Kumbhalgarh Wildlife Sanctuary
- Van Gujjar Landscape Intervention:
 - Kalpavriksh has been collaborating with the Van Gujjar Yuva Tribal sangathan with a focus on strengthening of community institution, documenting traditional governance systems of the Van Gujjar, revival of cultural afforestation festival- Sela Parv, conservation of the Van Gujjar inhabited landscape, with a focus on youth and gender inclusivity. The project includes activities like trainings and workshops, meetings, research and documentation.
 - Meetings and Workshops:
 - The training programme on Organisational development focusing on finance and accounts keeping took place on 22nd July, 2023. The venue for the meeting was in Sidhdhrodh, Haridwar Forest Division. The resource person for the training was Mr. Himanshu Sati, who has had experiences of working on issues related to forest conservation and was also informed about the Van Gujjar community. The meeting was attended by more than 20 individuals.
 - The training programme focusing on laws and policies relevant to the Van Gujjar community took place in Gujjar Basti, Haridwar forest Division, on 5th August, 2023. The meeting was facilitated by Pranav Menon, Phd scholar at University of Minnesota, and who is also a legal consultant for the Van Gujjar Tribal Yuva Sangathan. The training began with tracing the history of Van Gujjars, looking at archival documents relevant to the community, and towards



tracing forest and wildlife conservation laws, focusing on criminalization of the Van Gujjars.

- The National Working Group on Community Conserved Areas- chapter of the Indigenous and Community Conserved Areas global Consortium (ICCA Consortium), a conservation and livelihoods learning and exchange visit was organised between the Van Gujjar community residing in Uttarakhand, and communities residing around the Wular Lake, Kasmir. The visit was funded by Paul Hamlyn Foundation and was organised from 21st September to 28th September, 2023, in Wular Lake and five youth members of the Van Gujjars participated in the exchange visit.
- A one day meeting was organised in Gujjar Basti, on 28th October to discuss issues on gender inclusivity within the traditional governance system of the Van Gujjar community. The meeting focused on the lack of women's participation in decision making processes of the community, and strategies of addressing the issue. The meeting also led towards discussions on the need for facilitating more meetings of the sort, in order to provide a space for women to discuss the challenges that women face in inclusive governance.
- A three day exchange visit program was conducted in Biligiri Ranganatha Swamy Temple Tiger Reserve in Karnataka from 3rd to 5th December 2023.
 Four Van Gujjar youth took in the exchange program - Neema P. Broome, Akshay Chettri
- A workshop on womens' health was organised at Kathyari, Gujjar Basti, District Haridwar on 25th December, 2023. The discussion was facilitated by Ms. Priyanka Sati, a medical practitioner at AIIMS, Rishikesh.
- A series of workshops, meetings and trainings were organised between 5th and 12th February, 2024. The week-long program included participants from the Van Gujjar community, Himal Prakriti (Munsiari, Uttarakhand), Dibang Valley (Arunachal Pradesh), Maldhari Mahila Manch (Gujarat), Holdeen Foundation.
- Van Panchayat Munsiari:
 - The local team of four members have been working on the history and current status of ownership, management and the use of the natural and cultural resource base of 3 Van Panchayats.
 - Initiated the development of a participatory biodiversity inventory of the Mushrooms and wild flowering plants of the monsoons and medicinal herbs and plants of the cool temperate region of the Gori valley as well as the formulation of a management plan with a focus on climate change adaptations.



- Organised the 'Himal Kalasutra' festival which included birds, butterfly and moth festival, Mesar Kund Mela, movie and documentary screenings. The festival was attended by school children, researchers, community members, tourists amongst other attendees.
- The local team has built a village level library to generate more awareness on issues of environmental protection and human-nature relationships.
- The team have also been conducting plantation drives in the Van Panchayat forests.

B.3 Bhimashankar Conservation and Livelihoods Programme

B.3a Empowerment of Vulnerable Communities

In Maharashtra, there are three Particularly Vulnerable Tribal Groups (PVTGs): the Kolam, Madia, and Katkari communities. Some Katkari families reside in the villages of Bhomale, Bhorgiri, and Kharpud. These families often migrate in search of livelihoods, resulting in a lack of essential government records and documents, such as Aadhar cards, ration cards, PAN cards, and caste certificates.

After extensive follow-ups and discussions with the Tahsildar and the Project Officer of the Integrated Tribal Development Project (ITDP), we successfully organised a camp on March 28, 2023. This camp aimed to provide the necessary government records to these underserved communities. Over 150 individuals, including 96 from our project villages and others from surrounding areas, received caste certificates and other essential documents during the camp.



B.3b Workshops and Training Programs

- 1. **Bhivegaon SHG Workshop:** On April 14, 2023, we organised a workshop for the Self-Help Group (SHG) members of Bhivegaon village. The workshop focused on the Gram Sangh process and the National Rural Employment Guarantee Act (NREGA), with 33 women participating.
- 2. Kharpud and Mhasewadi SHG Workshop: On May 11, 2023, we conducted a workshop for SHG members of Kharpud and Mhasewadi villages on the Gram Sangh process and NREGA, attended by 26 women.
- **3**. **Training on Processing Local Produce:** On May 28, 2023, a training session on simple processing and product-making from Karvanda, fig, mango, and Jamun was held for SHG members of Kharpud, Mhasewadi, and Khopewadi villages. A total of 48 women participated.
- 4. **Rajgurunagar Convergence Committee Meeting:** We successfully convened the Rajgurunagar Convergence Committee Meeting on August 14, 2023, at Panchayat Samiti, Rajgurunagar. During this meeting, we discussed the process for drafting management plans and arranging forest transact walks to better understand the various needs of the forest and village. We also explored possible funding support available through different schemes and programs.

Despite our extensive follow-ups to ensure the continuity of these efforts, we faced challenges in maintaining the momentum. Repeated attempts to schedule another meeting of the Rajgurunagar Convergence Committee with Mr. Balvant Gaikwad, Project Officer, and Mr. Pimple from the Integrated Tribal Development Project (ITDP) were unsuccessful.

- 5. Eco-tourism Livelihoods Training: We organised two livelihoods training programs on eco-tourism from August 17-19 and October 10-12, 2023.
- 6. **Bhorgiri Training on Local Grains and Fruits:** In collaboration with Bhorgiri Gram Panchayat, we organised a training program on August 29, 2023, focusing on processing and making products from raagi, varai, and fig. This session had 45 women participants.
- 7. **Bhorgiri Women's Workshop:** On September 7, 2023, with the support of the National Rural Livelihoods Mission (NRLM), we conducted a workshop with Bhorgiri women on the Gram Sangh process and the next steps for utilising received funds. This workshop was attended by 46 women.
- 8. Livelihoods Training in Bhomale: We organised a livelihoods training program for 12 women in Bhomale (Upper) on blouse stitching from January 15 to February 15, 2024.



- 9. Study Tour for CFR Management: On January 22nd and 23rd, 2024, we organised a study tour for village leaders, members of Gram Panchayats, and CFRMCs from Bhomale and Kharpud villages. The tour aimed to deepen understanding of the Community Forest Rights (CFR) management process and sustainable practices. Participants visited villages where CFR has been granted, namely Tokawde, Dahiwadi, and Mohagaon in Murbad Taluka of Thane district, Maharashtra. These villages have demonstrated exemplary efforts in actively managing and restoring their CFR forests. The exchange visit proved to be a valuable learning experience for our participants. Following the tour, there has been increased engagement in the micro-planning process of CFRs, reflecting a commitment to sustainable forest management and community-led conservation efforts.
- 10. Bhomale Village Training on NREGA: We organised a small training for women in Bhomale (Upper) village on the importance of Women Gram Sabha and effective NREGA implementation on February 18, 2024, with 45 women present.
- 11. Local Seed Bank Study Tour: On February 29, 2024, we conducted a study tour for local women to the seed bank of Rahibai Popere. Rahibai is a Padma Shri recipient and is also known as "Beej Mata," in Kombhalne village, Akole Taluka, Ahmednagar district.

B.3c Celebrating Local Culture and Sustainability

 Wild Vegetable Festival in Bhorgiri: On September 17, 2023, in collaboration with Koteshwar Women Gram Sangh, Bhorgiri, S. M. Supe Memorial Foundation, and BAIF organisation, organised a vibrant Wild Vegetable Festival at Bhorgiri. The festival received generous funding support from PHF and S. M. Supe Memorial Foundation, Pune.

This community event attracted over 400 participants, including locals and tourists alike. The festival commenced with a colourful procession showcasing a variety of wild vegetables, accompanied by traditional Bhalari folk music and songs. The event celebrated local culture, promoted sustainable practices, and fostered community engagement in the conservation and appreciation of wild vegetation.

- 2. Sahyadri School Wild Food Festival: On September 22, 2023, Sahyadri School near Darakwadi organised a wild food festival for their students, where Bhomale women showcased various wild vegetables used in their diet.
- 3. Wild Vegetable Festival in Kharpud: During the reporting period, in response to the demand from local women of Kharpud and Mhasewadi, we organised a Wild Vegetable Festival at Kharpud on October 23, 2024. This event was a collaborative effort with Kharpud Women Gram Sangh, S. M. Supe Memorial Foundation, Pune,



and Gram Panchayat, Kharpud. The festival received financial support from PHF, S. M. Supe Memorial Foundation, and Gram Panchayat, Kharpud.

The festival was attended by over 300 people, including locals and tourists. The event commenced with a procession of wild vegetables accompanied by traditional Dhol Tasha Pathak folk music, creating a vibrant and culturally rich atmosphere.

B.3d Meetings and Advocacy Work

- 1. **Review of Rejected CFR Claims:** During the reporting period, we were informed by a Divisional Forest Rights Committee (DFRC) member, Mr. Kiran Lohakare, that Yelavali, Garbewadi (Bhorgiri), and Bhivegaon CFR claims had been rejected. We followed up with him to review the unlawful rejection of three CFR claims. DFRC had a meeting on November 21, 2023, directing the District Level Committee (DLC) to review these claims.
- 2. Women Confluence in Bhorgiri and Bhivegaon: With the help of Koteshwar Women Gram Sangh, Bhorgiri, we organised a women's confluence of Bhorgiri and Bhivegaon on February 4, 2024, with 33 women participating.
- **3. Women Confluence in Kharpud and Mhasewadi:** We facilitated a women's confluence of Kharpud and Mhasewadi villages with Kharpud Gram Panchayat on February 5, 2024, attended by 73 women.
- 4. Challenges and Advocacy in Kharpud Village: Despite Kharpud village obtaining its Community Forest Rights (CFR) claim in January 2020, the Forest Department has continued to conduct forestry activities without the Gram Sabha's permission. Moreover, they have been hiring workers from outside the community, disregarding local employment opportunities.

In February 2024, the Forest Department initiated the digging of new water holes within the Kharpud CFR area without seeking prior approval from the Gram Sabha. In response, villagers, including women and youth, intervened and halted the work. They promptly requested a face-to-face meeting with forest officials to address the issue.

Initially, the Forest Department attempted to persuade villagers to allow the completion of ongoing work and made unfulfilled promises of future funding for projects suggested by villagers. However, the community remained steadfast in their demand for dialogue with higher authorities.

On February 19th, Forest Guard Mr. Lokhande met with villagers to discuss the matter but was urged to arrange a meeting with Range Forest Officer Mr. Kank from Chakan Range. This meeting, held on February 22nd, saw local women assertively



voicing concerns over the quality of forestry works, the utilization of traditional local knowledge, the specific needs of the area, and the livelihood requirements of villagers.

The outcome of this meeting included assurances from the Range Forest Officer to foster a collaborative relationship with the community, emphasizing forest conservation and local livelihoods. This engagement highlighted the proactive role of Kharpud villagers, especially women, in advocating for their rights and sustainable forest management practices.

- 5. Cultural Heritage and Women's Rights Confluence: On February 20, 2024, we organised a confluence for Kharpud and Mhasewadi women on cultural heritage protection, women's unity, effective agitation for rights like CFR and NREGA, and the importance of Mahila Gram Sabha, attended by 74 women.
- 6. Women's Initiative at Enercon Windmill Project: In the vicinity of Kharpud, the Enercon Windmill Company has undertaken a project, with promises of Corporate Social Responsibility (CSR) funding for the repair of Mhasewadi ZP School. Despite assurances, the funding and repairs did not materialise.

Frustrated by the lack of action, local women decided to take matters into their own hands. On February 20th, 15-16 women staged a demonstration at the Enercon windmill site, halting repair work until their demands were met. Although Mr. Sharma assured them work would commence by February 26th, this commitment also went unfulfilled.

In response, the women intensified their agitation. They submitted letters to the local police station in Rajgurunagar and blocked the windmill road, staging a two-day sit-in on February 27th and 28th, 2024. Despite facing threats of arrest and persuasion from various quarters, including village men with vested interests and company officials, the women remained resolute in their protest.

Finally, on the evening of February 28th, the windmill company sent a lorry loaded with materials for school repairs. Upon the lorry's arrival, the women ceased their demonstration. This incident marks a significant milestone as it showcases the women's determination and perseverance in advocating for their community's educational infrastructure, despite facing considerable challenges and opposition.



B.3e Ongoing Projects and Initiatives

- 1. **FRA Implementation Support:** We are assisting Parsul village with FRA implementation and following up with SDLC for CFR rights. We continue supporting Kisan Sabha in Ambegaon Taluka for effective FRA implementation and helping individuals from nearby villages (Ahupe, Nigdale and Undekhadak) with individual forest rights claims.
- 2. CFR Management Plans Drafting: We have initiated the process of drafting Community Forest Resource (CFR) management plans for Kharpud and Bhomale (Upper) villages. This involved conducting several meetings with villagers to gather input and ensure community involvement.

As requested by the Project Officer (PO) of the Integrated Tribal Development Project (ITDP) office in Ghodegaon, we drafted and submitted rough management plans for these villages. Despite our numerous meetings and follow-ups with the ITDP Ghodegaon office to conduct trainings for the CFRM committees and organize transact walks in the CFR areas, their participation was not forthcoming.

Undeterred, we decided to proceed independently. We conducted two transact walks in both villages to better understand the area and assess the needs of the local community. In Bhomale (Upper), we carried out a transact walk and village map drawing exercise with local residents on February 18, 2024. Similarly, we conducted transact walk exercises in the Kharpud CFR area on February 19 and March 4, 2024. To complete the assessment, three more days of transact walks are needed in the Kharpud CFR area.

- **3. District Convergence Committee Nomination:** At the request of ITDP, Ghodegaon, we nominated Kalpavriksh Member Mrs. Neema Pathak-Broome as an NGO representative on the Pune District Convergence Committee.
- 4. Women's Active Participation in Gram Sabhas: In Kharpud and Bhomale, women actively participate in Gram Sabhas, addressing issues like water and sanitation, women's health, Gram Sangha process, employment opportunities, women empowerment schemes, and pension plans for widows, aged, and single women. Monthly meetings of Bhorgiri and Bhomale Women Gram Sangh continue regularly.
- 5. Village-Level Meetings and Trainings: We organised various village-level meetings, training, and workshops to raise awareness about legal spaces and government schemes, empowering villagers, youth, and women to become more participatory, transparent, and self-sustainable.



- 6. Facilitating EVDC, JFMC, SHG, and Women Gram Sangh Meetings: We facilitated meetings of EVDCs, JFMCs, SHGs, and Women Gram Sanghs in Yelavali and Bhomale.
- 7. Organic Kitchen Garden: Near Kalpavriksh's Bhimashankar field office, we started a small organic kitchen garden using local seed varieties and organic fertilisers.
- 8. Facilitating NREGA Implementation: We have been facilitating the implementation of the National Rural Employment Guarantee Act (NREGA) in Kharpud and Mhasewadi villages. Our efforts included organising several meetings to raise awareness about NREGA and its potential to alleviate unemployment. This year, we assisted the Kharpud Gram Panchayat in submitting various work proposals under NREGA, including cement bunds, Panand roads (access roads to water bodies and agricultural fields), two ZP school compounds, de-silting of two Pazar talavs (percolation dams), and a nursery. However, the process stalled due to a lack of support from the Panchayat Samiti and Tahasildar office. Despite this setback, we continue to follow up with the Assistant Program Officer (APO) of NREGA at the Panchayat Samiti in Rajgurunagar to improve NREGA implementation.

In August and September 2023, we held two joint meetings with the Block Development Officer (BDO) and Tahasildar to urge the implementation of NREGA in tribal villages. Unfortunately, the BDO expressed opposition to Kalpavriksh's involvement, citing claims from a previous Gram Sevak that Kalpavriksh was negatively influencing local people against government agencies.

- **9.** Establishing Eco-Tourism Campsite: We successfully established an eco-tourism campsite run by Katkari tribal youths at Bhomale (Upper). This small-scale business generated approximately Rs. 1,10,000 within four months.
- **10. Youth Meetings:** Under the TdH-supported project, we conduct meetings with youth on local governance and livelihoods and hold sessions with school children on their environmental child rights. We also organised three workshops on governance and ecology for the youth.
- 11. **Supporting Independent Research:** We assisted Baba Mayaram, an independent researcher from the Vikalp Sangam process, in writing a story in Hindi on Yelavali village, focusing on environmental and livelihood protection. This story is available on the Vikalp Sangam website <u>here</u>.
- 12. Advocacy for Forest Land Allocation: For the past two years, our team member Mr. Subhash Dolas has been advocating for permission to allocate forest land for Yelavali's new road construction. This issue has been raised at various levels of government departments, including the Forest Department's wildlife wing, the Public



Works Department, Pune Collector office, ITDP office, Pune Zilla Parishad office, and with local MLA and Panchayat Samiti members.

13. Facilitating Local Committee Meetings: Our team members Suvarna Bhomale and Subhash Dolas actively participate in meetings of the Bhomale Joint Forest Management Committee and Yelavali Eco-village Committee, respectively. They are involved in discussions regarding the usage of funds received under the Dr. Shamaprasad Mukherjee Yojana.

B.3f Youth Empowerment for Sustainable Development

- 1. **Nature-Based Livelihoods Training:** On 17th and 18th August 2023, we conducted a two-day Livelihoods Training Programme focused on Nature-Based Livelihoods. This training covered topics such as nature-based tourism, guide training, tour operating, and hospitality. A total of 29 youths participated in this programme.
- 2. Eco-Tourism Training: From 10th to 12th October 2023, in collaboration with Shivneri Trekkers, the Forest Department (WL), Pune, the Integrated Tribal Development Project (ITDP), Ghodegaon, and the Maharashtra Tourism Department, Pune, we organised a three-day training on Eco-tourism. This training saw the participation of 47 youths.

3. Exposure Visits:

- The first exposure visit was organised to Hivare Bazaar and Patoda villages in Ahmednagar and Chhatrapati Sambhaji Nagar (initially known as Aurangabad) on 11th and 12th March 2023. These villages are well-known models of local and sustainable governance in Maharashtra. A total of 45 persons, including six Kalpavriksh staff, participated in this visit.
- The second exposure visit for 37 youths was organised at the nearest eco-tourism campsite in Mhatarbachi Wadi in Ambegaon Taluka of Pune District on 17th and 18th November 2023. This campsite is managed by the Mata Varsubai Tribal Women Self-Help Group of Mhatarbachi Wadi.
- 4. Ecology Workshop at Arala River Camp Site: We organised a two-day workshop on Ecology at the newly established Arala River Camp Site. This campsite is a result of our previously mentioned tourism trainings and was started by Katkari (one of the three Particularly Vulnerable Tribal Groups (PVTGs) of Maharashtra) youths of Bhomale (Lower) under the guidance of Kalpavriksh. A total of 92 youths participated in this workshop.
- 5. Arala Valley Campsite Initiative: Twenty youths from the Katkari tribe have started the "Arala Valley Campsite," an ecotourism centre, under the support and guidance of Kalpavriksh. These youths expressed a strong interest in starting the ecotourism centre and requested Kalpavriksh's assistance. To support this initiative, we conducted



a series of meetings and discussions with the youth group and their families. We provided basic supplies such as tents, carry mats, solar tent lights, and blankets for their ecotourism centre. It is a matter of pride that this group successfully managed two training programs conducted by Kalpavriksh and hosted two tourist groups at their campsite. They are performing exceptionally well.

- 6. **Ongoing Youth Engagement:** We conducted monthly meetings with youth groups from seven villages to discuss and support various initiatives and activities.
- 7. Child Rights Education: On 27th February 2023, we conducted a session on Child Rights with students of Kohinde Ashram School. Mr. Digambar Birajdar from Dignity Academia Foundation, Pune, served as the resource person. Additionally, on 28th July and 13th September, we conducted three sessions with 7th and 8th standard students on Children's Environmental Rights.
- 8. Celebrating United Nations Child Rights Commission Week: In November, we organised fun games, including some traditional and local games, with children from six villages to celebrate the United Nations Child Rights Commission week.

The Gatpo of Spiti: Current Traditional Governance system- A case study

Over the last three years, through this project we have been involved in documenting the traditional governance system in Ladakh called the *Goba* system/*yulpa* system. The intention of the study in Ladakh was to understand the current relevance of the system in the context of socio-cultural, economic, ecological and political transformations taking place in the region. Through our interactions with and reading the studies of the Nature Conservation Foundation team that has been working in Spiti valley for over two decades, we were informed of several similarities between the goba system in Ladakh and local governance in Spiti (Murali et al, 2021)¹. Especially, in the context of the traditional system still being quite intact with *gompa*,

nambardar (goba equivalent) and local deities all playing a role in polycentric governance (Carlisle and Gruby, 2019)².

This study focuses on Kibber village which is an agro-pastoral village, the last one on the traditional trade route to Ladakh and Tibet. One of the members of the core team of this project undertook the trip to Spiti in March 2023 to document initial findings. Due to floods in Himachal Pradesh, it was not advisable to visit the field in October as per the plan. Hence, the team is planning to visit next year in 2024.

This study is a collaboration between Kalpavriksh, and Nature Conservation Foundation (NCF). The team will publish its report next year.

Vikalp Sangam Facilitation Team Meeting

The Vikalp Sangam Facilitation team gathered at Serene Eco Village for three days (9-11th June 2023) to work on the tasks taken up during the last CG meet, discuss important proposals and catch up. True to its name, the venue offered a refreshing stay amidst nature with evenings spent watching fireflies. Participants brought offerings of food, fresh ideas and new perspectives, which resulted in a truly connecting and joyful gathering, renewing bonds of affection. This year's meeting was built upon last year's foundation, and went a long way into reaffirming our vision for better facilitating the VS' varied activities and goals.

Vikalp Sangam Core Group meeting

The Vikalp Sangam General Assembly (formerly known as the VS Core Group) met at Farmers' Share, Shoranur, Kerala from 3rd to 5th November. This visit was full of inspiration, our conversations made rich by the participants not only representing their respective organizations, but also bringing in their own personal experiences to deepen our dialogue. The meeting was joined by 30 VSCG organisations and discussions were held on



topics such as VS objectives, internal governance, VS manifesto, plans for next year among others.

Dialogue/meeting at PipalTree Fireflies Intercultural Centre on the Social, Ecological, Cultural and Religious dimensions of Pluralism.

The three most important challenges besetting humanity are:

1. The potentially devastating effect of climate collapse that threatens large scale species extinction.

2. The atmosphere of mist-trust and intolerance between communities from various/different

religious denominations threatening cultural, social and civilizational breakdown.

3. The "othering" (based on ethnicity, race, caste, gender etc) and persecution of "those not like us" becoming a norm rather than an exception (and conversely the drive towards homogenizing of identities by denying "pluralities" of life choices and world-views).

As a first step towards finding solutions, in the month of July 2022 a Vikalp Sangam (funded by donor agency Misereor) was held at the Pipal Tree (Fireflies Intercultural Centre) in order to discuss the various dimensions of the above challenges. The meeting was attended by a cross section of participants including young people, social activists, feminists, peace builders, researchers, environmentalists, story-tellers, academicians, artists, spiritual practitioners, and teachers. All agreed that the crises humanity faces are not only of social, political and ecological nature, but also of moral and spiritual dimensions. It is impossible to address the above challenges within the ambit of a toxic mix of fossil-fuel based economy on the one hand, and the ascendency of extreme polarization (cultural, ethnic, racial etc) on the other.

It was thus felt that the conversations initiated at the July 2022 Vikalp Sangam needed to be carried forward to influence the larger world in order to better strategize for meeting the above-mentioned challenges faced by humanity. However, it was also felt that in an international scenario which is marked by the shrinking space for discussions and which is increasingly repressive and intolerant of plural imaginations for a socially just and ecologically sustainable world, the Fireflies July 2022 discussions can only be taken forward by first addressing and taking into consideration the challenges faced by humanity vis-à-vis the issue of emerging intolerance of "pluralities" [a plurality of world-views and life choices]. Given this scenarios it was felt that as a second logical step to take the July 2022 dialogue forward, a dossier celebrating the idea of "pluralities" is the need of the hour. With this in mind, a meeting was held in Fireflies in 2023 together with a dossier exploring the intersections between the issues and themes mentioned below:



- a. Ecological resilience, climate crisis and biological diversity,
- b. Multiculturalism, pluralism, heterogeneity and social harmony
- c. Multiple spiritualities Inter-faith dialogue and religious tolerance
- d. Constitutional pluralism and secular ethic
- e. Sexual pluralities and gender justice
- f. Democracy, human rights and justice
- g. Role of culture and art in fostering plural and utopian imaginations for a better world

Bioregionalism Working group: a broad overview

Broad Overview of the Group

The group conducted two public events to disseminate its work and create a discourse around bioregionalism. New members joined, and there are discussions ongoing about organizing physical gatherings in the coming year. Other groups from the region have expressed interest in learning from and exchanging ideas with the Group.

The group convened monthly or bi-monthly meetings throughout the year. Anticipated for the next year are more action-oriented outcomes, as the group evaluates its work and strategizes for the upcoming steps.

Public Launch of the reports

The group organized release events as part of its ongoing launch series for in-house outputs. These events included in-depth discussions on coastal bioregions and the Teesta Multi-hazard mapping.

The website has been seeing marginal increment in visitors each month and also more engagement in terms of likes and comments on the stories. There is an increasing interest among the readers of the website to actively contribute to it either by writing stories or translating them.

The attempts to include more regional languages on the website has been materialising. Every month, the ratio of English:Regional Language stories is a good 60:40.

In the coming year, the key focus is to continue building regional language stories, either originally written or translated. The process of restructuring the website is underway. The goal is to improve navigation, reorganise the menu and include some sections to make the website more accessible to readers, especially new. We also aim to reach out to different kinds of writers to commission stories written specially for Vikalp Sangam. The attempt is to cover categories that are less covered and also spread the net to have stories from various regions.

2. Alternatives Course

a. Orientation program on Alternatives for young and budding activists in rural Maharashtra: Kalpavriksh organized a course titled- "Alternative Visions for India" from the evening of January 29, 2024, to the evening of February 1, 2024, at The Hidden Oasis near Pune. The course was exclusively designed for young individuals from rural or semi-rural regions of Maharashtra who work in civil society organizations dealing with various social and environmental issues, and was attended by 17 participants. The sessions were conducted in Marathi and Hindi. The main objective of the course was to provide a platform for reflection on the numerous crises that India is currently facing while enabling participants to ideate on their visions for the future. The course also aimed to focus on transformative initiatives and ideas that work towards addressing these crises, and to offer participants an opportunity to re-examine and challenge their own beliefs and ideas. Over three days, the course delved deeper into issues and transformative alternatives in the spheres of conservation, gender, economy, and governance. Kalpavriksh is anchoring a sub-group of the VS General Assembly, to prepare the template for a course on alternatives, that can be offered on site or online, for various durations and diverse kinds of participants. A draft is under circulation.

Ladakh movement for Constitutional safeguards

Kalpavriksh is facilitating national level support for the ongoing movement in Ladakh demanding Constitutional safeguards including 6th Schedule and statehood. This includes participation in online sessions by Youth for Himalaya and Friends of Ladakh, participation in solidarity actions in Pune, putting out a statement (see D7.a above), and co-organising webinars with NAPM and PUCL for people from Ladakh and across India to speak. Key Statistics

Some of the key statistics for the last one year are given below: Number of stories published – 11 Total readership – 23699 Average viewership per article – 2155 Average monthly readership - 1972 Articles fall broadly into three categories: Alternatives – 4, Political/Social/Economic Analysis – 5, Environmental Issues – 2

The year 2023-24 turned out to be a challenging one owing to some personal issues, resulting in a fewer number of articles published, dropping down from 17 to 11. Yet, the viewership of the website almost held steady, dropping just by 3%, and, in fact, the average viewership per article increased by 35%, a welcome development, indeed. This makes us confident that this year RED will increase on its previous readership numbers.

Outreach

Two important outreach initiatives took place in 23-24. RED sponsored the participation of our Kalpavriksh colleagues in November/23 at the "Art of Freedom" conference in Basel, Switzerland, in Novemeber, organized by the "Academy of Democratic Modernity", a Kurdish initiative. Milind Wani who attended the conference wrote an article for RED (https://radicalecologicaldemocracy.org/bella-cio-bella-cio-hope-comes-from-the-young-for-a-world-weary-socialist/) about the issues discussed in the conference and how they are relevant to our quest for ecological democracy. RED also sponsored another group of KV colleagues earlier in March this year at the World Social Forum in Kathmandu, Nepal. RED executed an important project this year to sharpen our communications and outreach initiatives. We hired a communications consultant to help us think through ways in which



we could engage with modern social media to increase our reach particularly with tech savvy younger readers.

Over the last few years, we have recognized that a vast section of society, which interacts with the world using social media, has minimal access to RED's message because of our sketchy presence there. And, for some time now, it has been one of our chief desires to rectify that weakness and create a vigorous and active social media presence for RED.

The 2024 Communications Strategy has pointed us in a new direction and Pooja Kishinani who joined RED earlier in the spring has started work on this new strategy,

focusing on the following platforms to increase our presence and accessibility:

- Facebook
- Twitter (X)
- YouTube (To be explored when we host webinars)
- Linkedin
- Google Groups/Mailing lists

Future Plans

The new Communications Strategy put an emphasis on creating a logo for RED, something we have been aware of as a lacuna on our website. The group which worked on the new strategy pointed out that a logo helps in establishing a visual recall, particularly in this age of information overload, and it would be critical to create one that sets RED apart from other visual platforms. A logo will also be a visual identity marker for social media platforms like Instagram, Facebook and WhatsApp.

For the last few years, we have been keen to explore new formats for spreading the word on "alternatives" including creative formats like videos, the audio-visual media and also illustrated or comic books. This year, finally, we have been able to experiment with a comic book illustration of the exciting subject of fashion, which unfortunately is marked by a high level of pathos and exploitation, a continuing hallmark of market fundamentalism. The writer, Alessandra Monaco, had herself worked as a business executive in the fashion industry and her disenchantment with it is expressed quite methodically and with genuine emotion in the article. Our colleague, Shaunuk Sokey, was able to turn Alessandra's first-person narrative into a precise and pointed critique of the fashion industry.

We hope to be able to take the next step towards audio and video production and coming out with creative comic and illustrated books to make our articles attractive for a wider



Readership. We also plan to host RED webinars over the next few months, where we interview

contributors and other folks who are envisioning and practicing alternatives all around the World.

In late July/early August the RED team is going to formulate a short/medium term plan for the website. We will then share it with the KV general body meeting in September in Pune.

Webinar series on Climate Fiction in South Asia: begun on 17 January 2024, Kalpavriksh and GTA are co-hosting a series of webinars focusing on climate fiction in the South Asian region. More information and recordings at:

Radical Democracy & Autonomy gathering: a group within the GTA Facilitation Team is planning for a physical gathering on this topic sometime in early 2025.

Democracy thematic working group: Formed at the GTA physical assembly in Kenya, this group is planning to organise dialogues, compile a bibliography, and prepare other materials that can feed into the proposed Radical Democracy and Autonomy gathering.

Dictionary of Terms: a sub-group of the GTA Assembly is preparing a proposal for a two year process to compile a dictionary of terms relevant to radical transformations and alternatives from around the world.

Weaving Alternatives Periodical: Every three months, a Periodical is released for the extended GTA community. The Periodical contains updates from the Weavers, the Endorsers and the Facilitation team of the GTA, along with specially commissioned articles and some re-published pieces. This year we were able to publish one general Periodical and three themed Periodicals.

GTA Mapping: We have been mapping the Endorsers and Weavers onto our platform GTAMap. Currently, cases from the three commissioned volumes (the two Resilience



volumes and the one Regeneration volumes) have been uploaded onto the map, and now all the webinars the GTA has initiated and hosted are being uploaded as well.

There is also a book being compiled of all the writings and the pieces of knowledge about the GTA's practices, narrating what the GTA has done. There has been a lot written already; this editorial group intends to bring all of this together that presents the GTA.

C.3 Other Activities (not project-funded through Kalpavriksh)

Western Himalayan Vikalp Sangam process:

The WHVS process began in 2016 and since then been has been co-led by the core member organizations such as Jagori Rural, Beej Bachao Andolan, Devalsari Environment Protection Committee, Himdhara, Maati, MAUSAM, Peoples' Science Institute, Shramyog, Snow-Leopard Conservancy India Trust, Titli Trust, Kalpavriksh and Himalayan Collective. Kalpavriksh for two years, supported the part-time coordination & facilitation of the process while the member organizations put together a comprehensive proposal for their joint activities under Vikalp Sangam process. The proposal submitted by the core team for funding has been accepted by Eicher Foundation.

Producing Alternative Green Futures' project: Advisory role in project 'Green Transitions' of Riskolde University (Denmark) and WITS University (South Africa), including hosting, advising, and making connections for PhD student doing fieldwork on alternative initiatives in India and on the VS process.

Manifesto for an Ecosocial Energy Transition from the Peoples of the South: Inputs to this document and subsequent promotion, emerging from EcoSocial Pact of the South and Global Just Transition (Institute for Policy Studies)
